Regular Meeting called to order, Pledge and Roll Call. Approved minutes of the regular meeting 11/21/23

Approved consent agenda: bills of \$50,144.51; eight past due utility accounts; no zoning permits issued.

- 1. The Truth in Taxation public hearing was opened. No citizen present. Public hearing closed.
- 2. S. Traulich with Bolton and Menk spoke to the council about some updates on funding for the 2nd ave project. The project was accepted on the PFA funding list and the project must be certified by June 2024. Council approved Bolton and Menk to continue on with the process, design, and reports for the project. The LRIP application was submitted. No movement on the Lead and Copper inventory-waiting on work order from the State.
- 3. Council approved increase in garbage bin rates for Clobes Sanitation for 2024.
- 4. Council approved the amendment to the code of ordinances 30.11
- 5. Dept heads: K .Kokesch reported MVTL rates to increase. Radermacher reported an update on the new recycle bins to come; spoke with council about upcoming classes and trainings; the City received a supply of emergency cots and blankets for the community center.
- 6. Approved 2023 Fire and MRU payroll
- 7. Council approved not to waive tort liability limits for property insurance renewal.
- 8. Approved required documents for new city prosecution attorney.
- 9. Approved 2024 Council Meeting Schedule.
- 10. Approved 2024 budget and levy.
- 11. Signs at the ball field were discussed and to be removed by owners.
- 12. Discussion held on future of the MRU and how to support it long term.
