nothing new to report—Radermacher recently learned that City Council may implement policies for the Fire and MRU Departments instead of having bylaws. Council will consider this change in future. K. Kokesch reported his vacation in June; he reported one property owner upset about the Lead and Copper line inventory; Kokesch talked about the benefits of completing the sump pump inspections. The lift E1 lift station break down reported last month was submitted for an insurance claim and successfully went through. Ball Park Bathrooms will soon be opened. Kokesch informed the council of a sewer line in town that is continuing to fail and may be asking for permission to install a private sewer system. Council approved paying half of a bill for maintenance repairs to a city storm sewer connected to agriculture field tile. Radermacher reported no new upOdated from Bolton and Menk, the mosquito spraying schedule has been set, the city wide clean up days and times have been posted, city hall needs to replace gutters, Gruendemann to look into quotes, the ball park will be regularly used until July for Cougar Rookie practices on Tuesdays. Radermacher informed council that Got Dirt removed the tree at the Lion's park and payment was approved last month for \$575; the whole payment was donated to the Fire and MRU departments. Radermacher also discussed address issues some residents are having—Radermacher intends to help correct issue.
