
Regular Meeting called to order, Pledge and Roll Call. Approved minutes of the regular meeting 4/9/25

Approved consent agenda: bills of \$41,762.54; nine past due utility accounts; one zoning permits issued for a 12'x20'x8' temporary storage/car port at 254 1st Ave E.

- 1. Deputy Wagner reported doing the first round of blight properties with Radermacher and will email the list out ASAP; second round to be done May 17th.
- 2. Traulich reported the wetland delineation to be complete for the Ravine project; easements are ongoing. Traulich spoke with council on financials with the 2nd Ave improvement project and discussed bids received, and how much funds will be needed after the grant award has been applied. Traulich discussed with council the possibility of not using PFA load to cover the extra funds needed to save on interest.
- 3. Approved Resolution 2025-4: Accepting bid for 2nd Ave project. Bid awarded to M & R paving
- 4. Dept. Heads: Menk reported the new Fire Department Officers; 1st Leut-Wes Lund, 2nd Leut-M. Minkel, Secretary-T. Johnson. Recent pump test went well. The old pumper need repair-approved for repair. There were two recent fire calls-one grass fire that got out of control and one mutual aid call with Fairfax. K. Kokesch reported the drinking fountain to have ben ordered. Kokesch will be taking a vacation in June. Park bathrooms are open. The same person will be mowing for the city as did last year. Radermacher reminded the council of two fire department applications. Radermacher reported an update on cannabis retail ordinances.
- 5. Council discussed Harmoning's utility request. After a lot of discussion, council denied the request but approved Harmoning to maintain a well.
- 6. A plan for the Lion's park needs to be made. A place for the benches need to be set along with plans for tree placement. Will there be plans for a sand volleyball court, and where? Gruendemann volunteered to help set plans and bring back to council at next regular meeting.
- 7. Approved dust control for 2025 with Southwest transfer at \$1.05 a foot. This will be done once for the 2025 calendar year.
- 8. Council approved having city attorney look at tree ordinance and assist in updating the ordinance to include wording for ash bore. Tre inventory was shared and discussion on creating a program to remove diseased trees was discussed.
- 9. Gruendemann reported the Cedar Mountain school board was working on bids for community center painting.
- 10. Approved camera placement of cameras at the water plant to watch the fire hydrant and the boat landing to prevent theft, vandalism, and unlawful dumping of trash.


